**NOTES**

This Price List is subject to periodic review.

The commission rates listed are basic and may increase or decrease in special cases.

This Price List includes the Bank's standard basic transactions and does not cover all possible cases. For that reason, you are advised to consult the relevant Bank officers before carrying out any transaction.

In cases of adjustments to pricing terms, if you disagree with the revised pricing, you may notify the Bank and terminate your contract without penalty and with immediate effect. If you do not notify us of your rejection before the new pricing terms take effect, it will be considered that you have accepted them.

**Lending Accounts**

Lending accounts are governed by the same provisions as deposit accounts with regard to:

- Cheques drawn on lending accounts
- Cheques credited to loans
- Cash deposits

**Deposit of Cheques/Securities**

The value dates applied do not protect the Bank against the return of unpaid cheques; therefore, appropriate safeguards must be taken to ensure that cheques are not released and drawn before the risk of return has been eliminated.

For the determination of value dates, all cities within the Prefectures of Attica, Piraeus and Islands are considered as one city, except for Erythres, Megara, Spetses, Hydra, Lavrio, Aegina, Salamina, and the provinces of Troizinia and Kythira.

Each Branch Manager has the discretion to refuse the deposit of cheques where, in the Manager's opinion, the prescribed value dates are insufficient to ensure successful collection.

Public holidays occurring between the date of deposit and the applicable value date are added to the number of days for determining the value date.

In the event that cheques credited to an account are returned unpaid, the relevant charge will be effected using the same value date as that applied to the credit, irrespective of whether the account is interest-bearing or interest-free.

Commissions for cheque collection are collected in advance. The return of unpaid cheques does not affect commissions already received.

**Value Dates for Post-Dated Cheques**

Post-dated cheques are deposited into lending or deposit accounts on the date of their issue, subject to the relevant value dates.

When the value dates of a cheque are reduced or the cheque is accepted as cash in accordance with approved limits, interest is charged at a rate equal to the MLR plus 2.5% on the reduced number of value dates.
